CALLED MEETING OF THE CONGREGATION SYNOPSIS OF SEPTEMBER 13, 2020

WE DID IT! Although highly unconventional (especially for conventional Presbyterians!), we managed to conduct a Congregational Meeting for the purpose of amending our Bylaws *in absentia*! The meeting was duly and appropriately called by both mail and email on August 28; notification was given as to the time, date, place, method, and purpose of the “meeting;” and notices were printed in the online bulletins and announced from the pulpit.

As Pastor Kim announced following Worship on Sunday, September 20, 2020, one hundred seventy-four (174) ballots were received (101 electronic and 73 paper). Both amendments passed, the first unanimously (174 to 0) and the second 172 to 2. The first amendment now allows FPCV to hold our Fall Congregational Meeting via Zoom, and the second amendment allows us to increase the size of the Session if needed to an odd number not to exceed fifteen (15) members. (Exact wording of those amendments is included below.)

Thank you to everyone for your flexibility and willingness to embrace new ways of being the Church in these unprecedented times!

1. The **first proposed amendment** allows for an electronic Congregational Meeting. This is an addition of Section 9 to Article V (Ecclesiastical Meetings) and reads as follows:

*Section 9: The polity and theology of the Presbyterian Church recognizes the importance of meetings of the church according to the Book of Order. There is no substitute for the richness of conversation and debate that is possible when we gather in one place to listen and watch and open ourselves to the work of the Spirit. There are circumstances, though, when being physically present with one another is impossible or impractical. During extraordinary times when we **must** use other means of accomplishing the business of a governing body when we cannot meet face to face, the following will be allowed: Virtual meetings by Zoom or another type of video conferencing tool, conference calls, email or postal mailings to gain the input from the congregation. (This policy is guided by the national church policy CM – 18 - Guidelines for electronic assemblies when participants are unable to meet face to face which was issued August, 2009. This information can be found on the PCUSA website which is www.pcusa.org)*

2. The **second proposed amendment** changes the wording of Article II (The Session), Section I and reads as follows:

*Section 1: The Governing Body of the local church is the Session. The body consists of the moderator, any other installed minister and **an odd number of elders not to exceed fifteen but no fewer than nine.** (Changed wording is indicated in **bold.**)*

SESSION MEETING SYNOPSIS

SESSION MEETING SYNOPSIS OF SEPTEMBER 23, 2020

(Folks are encouraged to read all the way to the end as there is a lot of important information included!)

So much is happening right now that last week's meeting lasted longer than usual. Much thoughtful discussion and deep conversation took place beginning as usual with Elder Training. Your Elders spend time each month reading and then discussing topics that help them discern what it is that God and the Spirit are guiding them to do in their leadership of this congregation. Currently, they are studying Part II of our denomination's constitution, the Book of Order. One statement which was somewhat surprising to learn was that FPC Valpo is not just an *individual* congregation but rather is bound together with other congregations which are *collectively* known as the Church. Another important point was that membership is determined *only* by profession of faith and *no other criteria*.

Elder Sharon Kinsey shared reflections on the Zoom Presbytery Meeting which she and several other FPCV members attended on September 22, 2020. She remarked how uplifting and meaningful the experience was, in terms of information regarding the Zoom General Assembly meeting, budgeting issues, fellow Elder Elizabeth Monroe's financial presentation, and especially the worship experience. She expressed much gratitude for the opportunity to participate.

Finance Moderator Elizabeth Monroe requested discussion regarding Session's Mission to tithe ten percent of our 2020 budget. The question presented was whether Mission Team's allotment should be ten percent of what was originally budgeted or ten percent of what the church does in fact receive through the end of the calendar year (in the event that the amount is less than what was anticipated primarily due to the pandemic). After much thoughtful conversation, the consensus was that FPC Valpo has an opportunity to trust in God and step out in faith by following a theology of abundance and give the ten percent of what was originally budgeted no matter what the revenues are. Elders will be good stewards, utilize restricted funds as much as possible, but believe that God will find a way to honor the pledge that was originally budgeted.

According to **Stewardship** Moderator Lisa Pavlopoulos, all members should have by now received stewardship letters beautifully designed by our own resident artist Ginger Boys. Pledge cards are requested to be returned by October 13 so that Celebration Sunday can take place on October 18. And although these are definitely uncertain times, we pray that all are able to support the church in some way and allow us to answer God's call to mission and ministry.

You will be hearing much more in the future about our being a **Matthew 25 Congregation**, but in the meantime know that a new Ministry Team will be formed to promote this new initiative which will be addressing the issues of building congregational vitality, dismantling structural racism, and eradicating systemic poverty.

Session was then updated by the **Community Task Force** about the fact that the building IS now open for Small Groups and community meetings as long as they follow proper safety guidelines which have been provided and sign the waivers *required* by our church insurance company. The next step is opening the sanctuary for Sunday morning worship, and they are working diligently to make that happen!

At the August Session meeting, the **Chancel Visioning Team** presented a recommendation to pursue an evaluation of our sacred space and technology, but the issue was tabled. The team then offered a Q & A session via Zoom in early September which allowed elders to glean more information regarding the proposal to hire Elevate Studio, a faith-based organization which specializes in designing sacred spaces. Considerable discussion included the financial commitment (payment on an hourly basis not to exceed a set amount); the purpose of the study (ministry and total worship experience, not simply superficial and/or decorative); and the primary importance of the technological component assessment. Despite a variety of opinions on both sides, a consensus was reached to at least pursue the first steps in achieving this goal.

SESSION MEETING SYNOPSIS OF SEPTEMBER 23, 2020, CONTINUED

Another very important topic concerned the selection of an **Associate Pastor Nominating Committee (APNC)**. Back in June, Session was visited by members of a Discernment Team (Jim Hubbard, Paul Knauff, Linda Long, Jennifer Burns-Lewis) who presented a model for a 3-person staff for FPC Valpo with a possible re-alignment of duties. (This model was obviously based on a *pre-COVID* scenario!) In response to this presentation and after serious discussion, Session unanimously approved directing the Congregational Nominating Committee with the task of selecting an Associate Pastor Nominating Committee (APNC). In the June 24 Called Session Meeting Synopsis, it was noted that this process will “probably take a year to a year and a half due to the fact that a congregational mission study will likely need to be completed.” It will be *after* that mission study is completed that the committee will determine what the primary needs of our church are in terms of staffing and only then will we know precisely what we are looking for; then the search can actually get under way. To *begin* the process, we propose to elect that APNC, hopefully in the near future.

Among many other topics that were discussed, the following two are noted:

- **Budget** requests for 2021 have been submitted to the **Finance Team** who will begin drafting a tentative budget for next year.
- **Building & Grounds** team requested funds for a new roof for the Pavilion. A motion was approved to take the funds from the Capital Building fund.

If you would like more information, please read the detailed minutes which will be *posted in the glass-enclosed announcement board* in the Hospitality Center once they are approved (and we are allowed back into the church!). **In the meantime**, please contact any of the Elders and/or the Clerk if you have questions or are interested in further details.

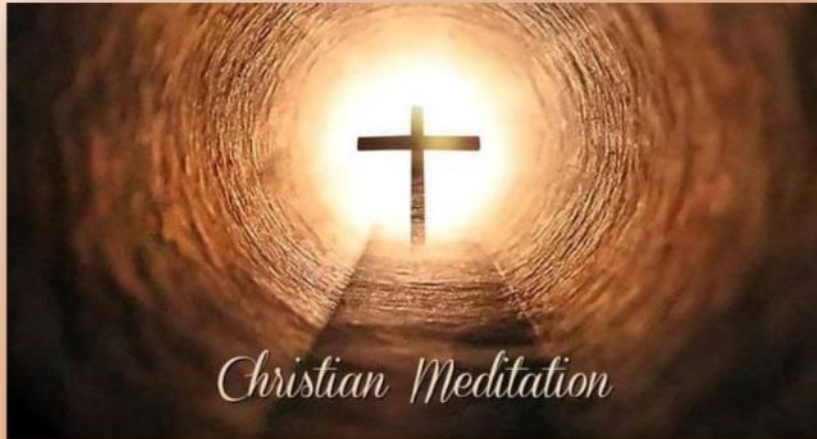
